# Reflections From The Director

#### Celebrating 25 years of service to the women of North Queensland.

NQWLS has much to be grateful for as we review another year of hard work.

We all continued living with the uncertainties and impacts of COVID-19 and at NQWLS we also continued to learn and embrace new ways of working. These new ways of working have served our clients well, with more services provided for women for the year ending 30 June 2021, than in any year before.

We found new ways to provide legal help to women living in rural, regional and remote communities in Queensland. We provided legal advice often as a 'same day, every day' service by phone and videocall. We maintained face-to-face appointments for the women who needed them and had the greatest level of complexity in their circumstances. We provided remote advocacy and representation in courts as far away as Mareeba, Mt Isa and Thursday Island. We reached out further than ever across our service region with our 'wrap around' complex casework service. We visited every one of our fifteen (15) outreach partners from Mackay in the south, to Cooktown in the north. We presented new customised community legal education workshops and engaged in new ways with our community outreach partners. We participated in powerful work calling for changes in policy and the law, both in our own capacity and as a member of the Women's Legal Services Australia (WLSA) network. The number of legal services delivered increased from just under 12,000 in 2019 pre-COVID to nearly 15,000 this year. This represents an increased level of services for women by around 25%. The staff and management team at NQWLS have been nothing short of amazing and I am grateful to everyone of them for their dedication to the vision, values and mission that guide us in our work.

Many of the staff, management committee, general members, life members, friends and supporters of NQWLS have enjoyed reflecting on the achievements of '25 years of community service' which is the fantastic milestone that we have reached this year. Their reflections have been collated and many of them are shared in this year's Annual Report. It is my personal privilege to have been part of the committed group of volunteer women who worked together to establish a 'free legal service for women' in the early 1990s and who lobbied successfully to obtain the first funding grant in 1996.

Our records show that between 1996 and 2021, NQWLS has provided more than 125,000 free legal services for the benefit of women and their children.

For many of those women, this help has been lifechanging. Our clients' have provided their feedback and together with the stories that are shared in this year's Report, give us a glimpse into the empowering and vital work that has been done.

Last year, we called for more collaboration, more commitment to change and more resources to support us in the goal of ending violence against women. This year, I am very happy to say that we got what we called for.

NQWLS played its part in an amazing feat of collaboration and commitment to change when we marched in solidarity with thousands of women across Australia for March 4 Justice (M4J). With less than a week to get organised, NQWLS took a lead role and coordinated the M4J event in Townsville and Hayley was invited as a keynote speaker at the March in Cairns

We worked hard with our sister-service members of WLSA to deliver a pre-budget submission to the Federal government with detailed costings calling for increased resources to meet a sky-rocketing need for free legal assistance for women who had experienced domestic violence.

We are heartened because our submissions were heeded by government and an historic funding allocation of \$129 million was provided in the Women's Budget Statement to support the work of 'women's legal centres' across Australia.

NQWLS and the women's legal centres of Australia thank the Federal government for hearing the call to help us, help more women in crisis. NQWLS is also grateful to our Queensland government and Attorney-General, Shannon Fentiman, for supporting NQWLS' work for women and for the allocation of this new funding to the three (3) Queensland women's legal centres. More free legal services will now be available to women who need them across the State and new programs will soon be established.

#### Happy 25th anniversary, North Queensland Women's Legal Service.

I give my sincere thanks and appreciation to everyone who has been part of the NQWLS story and who has contributed to its work over the decades - whether as a staff member, a management committee member, a volunteer or supporter. Your work has made a difference. Let's celebrate all the achievements, large and small, that have meant so much to so many.

Finally, at this important milestone for NQWLS, may I also say thank you to our colleagues in every Community Legal Centre (CLC) across Australia. It is important to remember that we are all part of a nationwide network of CLCs, working to achieve increased access to justice for those in need. CLCs know how to put the 'UNITY' into comm-UNITY.

There is still a great deal of work to be done of course. Let's maintain the NQWLS vision and see what can be achieved in the next 25 years!

# Quality, Accessible Legal Services for Women

Similar to last year, COVID-19 has had a huge impact on NQWLS and the women that it assists. However, the NQWLS staff team rose to the challenge and delivered nearly 15 000 services – a Service record!

Given the restrictions as a result of COVID-19, the majority of services were delivered via telephone or video conferencing. For many women this model of service delivery was very successful as it allowed same or next day legal advice in the comfort of their own homes, or wherever they happened to be, overcoming issues such as difficulty accessing transport or childcare if they had needed to attend an appointment in person. For some more vulnerable women however, remote service delivery is challenging, so for those women NQWLS continued to provide face to face appointments whenever possible.

NQWLS is proud to offer holistic, trauma informed services to all women who contact us, and we work closely with other services, especially specialist womens' and domestic violence services to ensure that women are able to have all their legal and non-legal needs addressed. Working closely and collaboratively and sharing information between support workers and lawyers means that women feel supported and do not have to retell their stories repeatedly to each different service. Having an in depth understanding of domestic violence, as well as an understanding of the impacts and presentation of trauma, means that NQWLS lawyers are able to work with women in a way that is efficient and effective at resolving their issues and increasing their safety, whilst being as nontriggering and empowering as possible.

#### **Domestic Violence Duty Lawyer Service**

Throughout YE2021, NQWLS lawyers provided advice and representation to over 2000 women who were involved in domestic violence proceedings in the Townsville and Cairns Magistrates Courts.

The value of this service cannot be overstated with feedback from women consistently stating how invaluable the service was and how they could not have done it without the assistance of the duty lawyers. Attending court is always stressful, however for many of these women, going to court and facing the perpetrator of the violence against them is triggering and overwhelming.

The trauma informed model practiced by the NQWLS lawyers assists women to feel more comfortable, supported, and able to articulate their story and achieve safer outcomes.

### Family Advocacy and Support Service (FASS)

NQWLS also delivered duty lawyer services to women appearing in the Federal Circuit Courts in both Cairns and Townsville through the FASS.

Although the numbers of women assisted are smaller than the domestic violence duty lawyer service, the outcomes for women are huge.

As part of the FASS, NQWLS lawyers have provided advice on what are often complex family law matters, drafted documents for women, negotiated with the other parties, and represented women in court. Again, the women that we assist through the FASS model have all experienced domestic violence by their partners/spouses and having lawyers who practice holistically and from a domestic violence and trauma informed perspective not only assists

women with their immediate legal needs at court but helps empower them and support them through the long and difficult family court process.

#### Domestic Violence Legal Service (DVLS)

The DVLS has been operating as part of NQWLS now since 2016 and during this time has achieved some remarkable outcomes for women. The DVLS is a holistic, wrap around complex casework service providing ongoing court representation for those women who are the most vulnerable and most in need of support and assistance. The holistic nature of the service means that women are supported to have all their legal and non-legal needs met.

The DVLS lawyers provide the legal assistance and support in relation to their domestic violence, family law, child safety, Victim Assist and any other legal matters they may be facing. At the same time, the Client Support Worker helps meet any non-legal needs including, financial, housing, counselling, health and mental health issues, through information, support and referrals.

It is our strongest wish that all women who contact NQWLS can be offered this level of assistance if required and that the funding committed to Women's Legal Centres by the Commonwealth and State Governments will go some way to achieving this.

#### Community Legal Education (CLE)

CLE is an integral part of any community legal centre service model and NQWLS is no different. Each year we deliver a variety of CLE sessions to a range of audiences. During this year, our Ask NOLA webinars ran monthly on topics including Child Protection Orders & Processes, Co-Parenting During COVID-19, Applying for a Divorce, Responding to a Domestic Violence Application, Relocation & Recovery of Children, Domestic & Family Violence in a LGBTI Context and, Independent Children's Lawyers & Family Reports.

Ask NOLA was designed as a CLE program to educate community workers to help them identify legal issues that their clients may present with and then provide appropriate assistance and referrals. Being webbased means that any worker, anywhere can attend the webinars, which is so important given the huge geographical area NQWLS services.

The easing of COVID-19 restrictions meant that face to face CLE was able to resume during the year. NQWLS lawyers shared their knowledge with fellow lawyers as presenters at the Children and Families Legal Assistance Forum (CAFLAF) Domestic and Family Violence Training Workshop. We were also invited to speak at the Family Law Practitioners Association (FLPA) CPD event where our Principal Lawyer took the opportunity to encourage local lawyers to be as 'DV informed' as possible and prioritise safety when working with clients.

NQWLS also delivered workshops to local domestic violence workers on how to draft domestic violence applications, as well presentations to Act 4 Kids and the Churches of Christ DV Survivors Group about domestic violence and domestic violence orders. We were again invited to talk to the 4th year Social Work students at JCU about the intersection between the domestic violence, family law and child protection systems, also to speak with a 'grandparents raising grandchildren' group about some of their legal issues, as well as appearing on local community radio during Domestic and Family Violence Prevention month to raise awareness of domestic violence and the help that is available. Our lawyers also presented sessions around domestic violence and family law at the Innisfail Community Support Centre and the Burdekin Neighbourhood Centre.

NQWLS updated its existing self-help resources and produced several new CLE resources including family law factsheets on the topics of spousal maintenance, parenting after separation, moving with children after separation, and grandparents and family law amongst others. A series of factsheets to help women who are involved in domestic violence proceedings were also developed, along with the first of a series of booklets designed to help women who are self-representing at domestic violence hearings. A Recognising Red Flags – Power and Control in a Pandemic factsheet was produced in response to new perpetrator behaviours and tactics that NQWLS was seeing as an emerging issue during the COVID-19 pandemic.

#### **Law Reform**

Equally as important as CLE to the community legal sector is law reform and NQWLS again had a busy year on this front. NQWLS provided a comprehensive submission regarding women's experiences in the justice system and the criminalisation of coercive control to the Qld Women's Safety & Justice Taskforce. We also made submissions to the Royal Commission into Violence, Abuse, Neglect, and Exploitation of People with a Disability and made recommendations calling for reforms to the domestic and family violence legal framework to better protect women with a disability.

As a member of Women's Legal Service Australia (WLSA), NQWLS contributed to submissions to the Standing Committee on Social Policy and Legal Affairs Inquiry into Family, Domestic and Sexual Violence, the National Framework for Information Sharing between the Family Law, Family Violence and Child Protection Systems, the Family Law Amendment (Federal Family Violence Orders) Bill 2021, and to the Review of the ban on direct cross examination in family law proceedings. Through these submissions

WLSA, and NQWLS, continued the tradition of fearlessly advocating for laws, processes, practices and systems that promote the safety of Australian women and children.

NQWLS also contributed to the submissions made by the Queensland Law Society on such varied topics as: improving the family safety competency of legal practitioners, the practice direction regarding privileged counselling communications, the domestic and family violence best practice framework for legal and non-legal practitioners, protection for temporary visa holders experiencing domestic and family violence, a new decision making framework for property matters in family law, a national consistent definition of domestic and family violence, as well as submissions regarding , the National Framework for Information Sharing between the Family Law, Family Violence and Child Protection Systems, the Family Law Amendment (Federal Family Violence Orders) Bill 2021 and to the Qld Women's Safety & Justice Taskforce and Inquiry into Family, Domestic and Sexual Violence.

#### Case Example 1

# Help for Simone and Ben

Women have been disproportionately affected by the COVID-19 pandemic in almost every area of their lives. Women are over-represented in the industries which have been hit hardest by the economic impacts of COVID-19.

They are the ones who were and, in many cases still are, providing care and education to children when they need to be homeschooled, and unfortunately rates of domestic violence perpetrated against women by their spouses or partners during lockdowns skyrocketed.

NOWLS has seen a significant increase in women contacting the service for help with legal issues that have been created or exacerbated by COVID-19.

The pandemic has provided violent and controlling men with new tactics to use against their victims, including using COVID-19 itself as a reason to withhold or threatening to withhold children. NQWLS gratefully received additional funds during YE2021 to provide frontline legal services to help women impacted by both the pandemic and domestic violence.

Simone contacted NQWLS after her ex-partner Marty refused to return their 5-year child, Ben, after spending time with him. Simone had been a victim of domestic violence throughout their relationship and despite now living 1000's of kilometers apart, still suffered regular abuse from Marty and attempts to control her. Simone and Marty had a parenting plan in place which provided that Ben live with Simone in Far North Queensland and spend some time during school holidays in Sydney with Marty. At the time that Ben was to travel to Sydney, it was a declared COVID-19 hotspot, however Simone and Marty negotiated an agreement that Ben and his father would spend the time in rural NSW with Ben's paternal grandparents. Marty did not comply with the agreement and took Ben straight to Sydney, against Simone's wishes. He then contacted Simone and told her he would not be returning Ben to her until the end of the pandemic.

NQWLS discussed Simone's options with her, including applying to the court for an urgent recovery order to have Ben returned to her care. Simone was reluctant to go to court so NQWLS wrote to Marty to try and negotiate Ben returning to Simone's care, including a proposal where Simone flew to Sydney, did 14 days quarantine with Ben, and then could return with him to Far North Qld. Unfortunately, Marty was not agreeable to anything that Simone proposed so she was left with no option but to apply to the court.

NQWLS assisted Simone to file urgently in the Federal Circuit Court seeking that her matter be dealt with urgently under the Court's new COVID-19 list as being directly related to or as a result of the COVID-19 pandemic. Simone's application was accepted as a COVID-19 matter and heard urgently. Ben was returned to her care and orders were made confirming that Ben lived with Simone. NQWLS then assisted Simone to apply for a grant of legal aid for representation in the ongoing proceedings regarding the time that Ben was to spend with his father.

#### Case Example 2

# Collaboration with other services and overcoming language barriers

A woman contacted our phone advice service on a Monday telling us she had just been served with an urgent recovery order application filed by her child's father seeking that she return the child to SE Qld from where she had fled. The woman had fled to Cairns with the child after the father assaulted her.

There was a long history of DV, a DVO in place to protect her from him, repeated breaches of the DVO by him, and the DV was still ongoing.

The matter had been to court a few days before and she had been ordered to file her documents and appear in court again on Wednesday. The woman was from the Philippines and English was her second language. She did not have an interpreter at the first mention of the matter. The NQWLS lawyer booked her in for an urgent face to face appointment. The woman attended the office on Tuesday and with the help of an interpreter over the phone, her documents were drafted and filed. Again, the woman attended court without an interpreter but on the strength of the documents prepared by NQWLS, the Judge did not make the recovery order but adjourned the matter off until Friday but did say that she was considering making the recovery order.

The woman rang us quite distressed on Wednesday afternoon. She was fearful she would have to send her child back down south to his father. The woman came back into the office on Thursday and NQWLS

drafted submissions and filed a supplementary affidavit attaching some further details of the DV and DVO that we did not have the day before. The NQWLS lawyer then rang the Brisbane office of Legal Aid and arranged for a duty lawyer to appear on the woman's behalf the next day. The documents and submissions prepared by NQWLS were emailed through to the duty lawyer.

Legal Aid contacted us after court to tell us the recovery order had not been made after all. A lawyer had been appointed for the child, a Family Report was being done and it was going back to court in three (3) months time. Due to the risks he posed to the child (and the mother) the father was not given any time with the child at this stage.

The woman had applied for Legal Aid early on, however she had written the application for aid herself and it did not contain enough information so had been refused. NQWLS assisted the client with providing more information to Legal Aid and she now has a grant of aid for the remainder of the proceedings.



#### Case Example 3

# Safety at last wrap-around casework and support services for Rachel

Rachel approached NQWLS for help with her ongoing circumstances of domestic violence and protracted family law matters.

She said she felt defeated by the system and extremely vulnerable. She explained that she had obtained a Protection Order against her ex-partner, who was also the father of her children, only after years of extreme physical, sexual, verbal, and emotional abuse. However, due to continued breaches of the Protection Order she now wanted to vary the order to include additional conditions.

The NQWLS' specialist Domestic Violence Legal Service (DVLS) lawyer appeared in court for Rachel and was able to obtain an extensive Temporary Variation Order (TVO) for Rachel. The TVO named and protected their 2 children, included a residence condition, a no contact condition and prohibited her ex-partner from approaching or locating Rachel.

Sadly, Rachel's ex-partner continued to disregard the TVO and was ultimately charged with over 238 breaches of a domestic violence order, 2 counts of rape, and 1 count of unlawful stalking in a domestic violence setting.

As a result of his multiple serious criminal offences, Rachel's application was continuously adjourned to allow his criminal matters to progress.

This became increasingly frustrating and disempowering for Rachel. She wanted her application finalised and needed the certainty of the additional protections she was seeking.

Finally, after extensive negotiations between the DVLS lawyer and her ex's legal representative, Rachel's expartner agreed to consent without admissions to a final order in the same conditions as the Temporary Varied Order. Rachel's ex-partner also subsequently pled guilty to multiple criminal offences.

After the years of uncertainty and fear, upon hearing the news of this outcome from the DVLS lawyer, Rachel burst into tears. Her relief was palpable.

She was so appreciative the long-term legal casework and support provided by the NQWLS / DVLS team.

My name is Rae Greaves and I have been a worker at a Townsville's Domestic Violence Shelter for over 30 years. A few years ago, I was honoured to become a Life Member of the North Queensland Women's Legal Service along with one of Townsville's well known legal practitioners, Wendy Pack.

When I reflect back to the very early days of NQWLS, one of the most inspiring experiences from my work life has been witnessing the beginning and the growth of North Queensland Women's Legal Service (NQWLS). It all began when local legal practitioners and community workers saw the need for free legal advice for women who were experiencing coercive control from their partners or extended family members.

I was one of the early volunteers, rostered on a Wednesday night for two hours alongside a female solicitor, taking calls from women who wanted legal advice. There were many local solicitors who volunteered their time. Wendy Pack and Marjorie Pagani were two of the dynamos and a crucial part of the early days of NQWLS.

The free legal advice phone line continued for a few years before funding was finally granted – in recognition that this was a much-needed service and a vital part of helping women and children escape domestic violence.

Running the phone line and responding to the high level of calls for help called for a huge commitment from all of the women who volunteered their time. But, alongside the unpaid work, was a sense of camaraderie and passion for all of us who were involved. Lawyers and community workers came to

know and respect each other's work and some of us became life-long friends, united in a shared vision for a safer and more just world for all women, not just those with money.

I could never have imagined then that we would have the amazing NQ Women's Legal Service that we have today. It is a Service that continues to grow and develop in order to best support the women of North Queensland. I feel proud to refer the women I work with to the Service, knowing they will receive excellent legal advice in an accessible and respectful environment. I want to thank the staff of the Service and their amazing Director, Anne Lewis, for keeping alive our vision that began with a couple of local volunteers in an office at the Women's centre in Townsville, answering phones on a Wednesday night.

# March 4 Justice Speech

Thank you so much to you all for coming along today and thank you Ella for inviting me to speak. I would like to acknowledge the traditional custodians of the lands on which we meet today the Gimuy-Walubara Yidinji people and pay my respects to elders past, present and emerging and note their continuing connection to land sea and culture – sovereignty was never ceded – it always was and always will be their land. I would also like to acknowledge the particular contributions that Aboriginal and Torres Strait Islander women have made and continue to make to our community.

Why do I march today? I am sure it is for many of the same reasons you do - basically I am angry! I have been angry for a long time about the violence, misogyny and sexual harassment that is the reality of living as a woman in our society, but the response (or lack thereof) to the allegations of rape, bullying and sexual harassment in Parliament House, as well as to those against the AG has me raging! For our Prime Minister to accept at face value the denial put forward by the AG, without even reading the allegations, and then the only ones who have lost their jobs as a result of the allegations coming to light are the victims and those who dared to speak up and support them, pretty much sums up everything that is wrong with the system that allows men's violence against women to continue almost unchecked.

What sort of message does this send to our society – to my three daughters and my granddaughter? That they have to expect this to happen, that they have to accept it when it does, not to speak up because they will not be believed and, their life will be further destroyed if they do? And to my son? That he can treat women this way – sexually harass and assault them and there will be little if any consequences for him? No, enough is enough!

We need a comprehensive and urgent reform of our laws, policies and institutions to properly be able to

support and protect women and children and hold men who commit these behaviors to account. Our current system is failing victims miserably. A lot has been said about the rule of law recently – the rule of law means equality before the law, equality of access to the law and equality of protection by the law – the law and legal system is clearly not delivering this to women generally, but especially to those who are victims of sexual violence. In fact, it actually systematically retraumatises victims and in most cases without even a positive outcome for them.

We know this because women have told us this repeatedly. We also know this because less than 15% of rapes and sexual assaults are reported in the first place and of those less than 10% result in a conviction. The system is stacked against the victim and the way the trial process works the alleged rapist defends themself by attacking the victim and her credibility – taking the focus off him and his behaviour – what was she wearing, was she drunk, was she flirting, did she go off alone with him, does she have a history of engaging in casual sex? The history of the alleged rapist, including previous charges or convictions for rape and sexual assault do not come out during the trial process.

This is why I march today, to demand change. For myself, my family, my female friends and colleagues and for my clients - the 1000's and 1000's of women who I have worked with over the years to help them navigate and survive a system that actively works against them.

I march to demand change so that the extremely brave 16-year-old girl who reports a sexual assault to police is no longer asked what kind of underwear was she waring under the dress - a G-string? And the woman who reports being sexually assaulted by her housemate whilst having a shower is no longer questioned about what she might have done to cause it - well why did he barge in there, what did you do? Were you flirting with him beforehand? Or the woman who rang police distressed reporting her ex-partner had just sexually assaulted her but when police arrive, she is the one taken into custody and charged because they found some drugs in her room - her allegations were never addressed. These cases all occurred here in Cairns over the last 12 months. I could go on and on, but I won't.

But this is why I march.

I march for my Aboriginal and Torres Strait Islander sisters whose experience of violence is truly heart breaking, for my culturally and linguistically diverse sisters, my LGBTIQ sisters and for those with a disability whose, along with Aboriginal and Torres Strait Islander women, experiences of violence are huge and whose chances of justice and protection through our current systems and institutions is practically nil.

I also march for those 1000's of women who cannot, those who have paid the ultimate price and lost their lives as a result of male violence against women. Enough is enough!

We demand urgent societal and systematic change now – we must reframe the narrative – we don't have women's safety issues in our society – we have men's violence against women issues, and it must stop now, and change must start at the top. So, governments of Australia, you are on notice – we demand the right to be safe at home, at work and in the street.

WE ARE WOMEN - HEAR US ROAR.!!


