#### **Vision**


Access to justice for all women living in North and Far North Queensland.

#### ABOUT NOWLS

North Queensland Women's Legal Service (NQWLS) is a specialist community legal service providing free legal help and assistance to women. Operating since 1996 NQWLS provides free and confidential legal advice, information, education, referral and representation to women primarily in the areas of domestic and family violence, family law (parenting and property), child protection, Victim Assist, discrimination and sexual assault. NQWLS has a service area that covers the top half of Queensland, from Sarina in the south, to the Cape and Torres Strait Islands in the north and west out to the Northern Territory border.

NOWLS has offices in both Cairns and Townsville. A flexible service delivery model increases access to justice for women who live in more, rural and remote communities. Legal help is available through a variety of options including:

- » Face to face and telephone appointments
- » Free call 1800 telephone advice service
- » Volunteer evening advice service
- » Monthly face to face legal advice clinics in Ayr, Charters Towers, Ingham, Atherton, Mareeba, Innisfail, Mossman and Port Douglas
- » Monthly face to face advice clinics at the Townsville women's centre and domestic violence service
- » Skype appointments from "hot spots" in Mackay, the Whitsundays, Mt Isa, Ravenshoe, Kuranda and Cooktown

- » Telephone advice service for women in the Townsville Correctional Centre
- » Duty lawyer services at the Cairns and Townsville Domestic Violence Courts and Federal Circuit Courts
- » Complex casework, including court representation and social work services as part of the Domestic Violence Legal Service

NQWLS also has a well-established community legal education program through the AskNola website that provides free online webinars to community workers to help them identify legal issues that their client's may be facing and then provide information, referral and support to them. NQWLS also regularly delivers face to face community legal education sessions to schools and other community organisations.

NOWLS is informed by a feminist framework that recognises the rights of women as central and contributes to policy and law reform discussions, primarily focused on domestic and family violence, family law, and other issues that affect women to ensure that the law does not unfairly impact them.

#### THE YEAR THAT WAS

2017/2018 was another huge year for NQWLS with the Service continuing to expand and grow. The year also brought changes to the staff and volunteer team.

# **Staff Changes**

At the end of 2017 we farewelled Debbie Taylor and Moira McGovern from our administration team and welcomed Abi Juniper and Sylvia Aia Opu. Debbie and Moira left big shoes to fill however both Abi and Sylvia have been up to the challenge and have settled in well and become valued members of the staff team.

We also welcomed Nadia Whebell as the Cairns Domestic Violence Duty Lawyer Intake Worker, a role that is vital to the smooth operation of the Domestic Violence Duty Lawyer service each week. In Townsville Toni Millar joined us as Intake Worker after we said goodbye to Robyn Gee who had fulfilled this role for a number of years.

The end of 2017 also saw Client Support Worker Tania Young leave to undertake a legal traineeship with another community legal centre and in a first for NQWLS, we welcomed social worker Leonie Crowe to the team.

#### **Legal Services**

The year saw demand for NQWLS services increase dramatically with over 12,500 services delivered by the staff and volunteer team. Unfortunately though there were still many more women that we were unable to help. Those that we were able to received legal assistance at the Cairns and Townsville Offices through face to face, Skype and telephone appointments. Telephone appointments were delivered during the day by the staff solicitors or at night by our wonderful volunteer solicitors who donated their time as part of the Evening Advice Service. For those women

who reside further afield NQWLS solicitors travelled monthly to our outreach locations, Atherton, Mareeba, Innisfail, Mossman, Port Douglas, Ayr, Ingham and Charters Towers to deliver face to face legal advice clinics. Other more rural and remote women received advice via our Skype hotspots situated at Cooktown, Kuranda, Ravenshoe, Mt Isa, Mackay and the Whitsundays. The free call 1800 advice line continued to operate Monday through Thursday from 9.00am until 1.00pm and allowed women throughout our entire service areas to ring and speak directly to a solicitor.

NQWLS solicitors delivered Domestic Violence Duty Lawyer services to women involved in domestic violence matters at both the Cairns and Townsville Courts. The service provides vital advice, support and representation to women at a time when many are feeling overwhelmed by the Court process and extremely vulnerable due to having to face the perpetrator of violence against them in Court. NQWLS also provided the Family Advocacy and Support Service to women who were attending the Cairns and Townsville Federal Circuit Court for family law proceedings. The solicitors assisted self represented women who had experienced or were experiencing domestic and family violence, with legal advice, help with drafting documents, court representation and referrals to support services. Again, such a service is central to increasing women's access to and supporting them through the often traumatic family law court system.

#### **Community Legal Education**

Community legal education (CLE) is an important part of the work of community legal centres. Knowledge is power, therefore by providing information and education to the community on their rights, the law and the legal system we are increasing their ability to access and understand the legal system. Throughout 2017/2018 NQWLS broadcast a number of webinars to community workers, legal professionals and students on a wide variety of topics through our Ask Nola website. The webinars covered a variety of topics

including changes to the domestic violence laws, domestic violence order breaches, undertakings, grandparents and family law, the role of separate representatives, family law interim hearings, and travelling overseas with children. We were also fortunate enough to have a number of guest presenters who delivered webinars on changes to the Victim Assist scheme, writing Victim Impact Statements and elder abuse. Ask Nola is a free membership based online legal resource providing not only monthly webinars but also fact sheets, legal information, resources and a referral database.

Aside from Ask Nola, NOWLS presented a number of in person CLE sessions to various community organisations and continued to deliver the Healthy Relationships sessions as part of the Love Bites programs to schools through our ongoing collaborative partnership with Catholic Education as well as a number of local State High Schools. We were also again invited to present a feminist perspective on the intersection between the domestic violence, child protection and family law systems and their impact upon women to 4th year Social Work students at James Cook University.

#### **Law Reform**

Like community legal education, law reform is central to the work of community legal centres. NOWLS engaged in a number of law reform activities and policy debates throughout 2017/2018 to address systemic issues that impact upon and perpetrate injustices for women. These activities included submissions to the Australian Law Reform Commission's review of the Family Law System, the Australian College of Midwives Draft Position Statement on Domestic Violence, and improving the delivery of respectful relationships and sex education relevant to the use of technology in QLD State Schools.

Our Principal Solicitor Hayley, was part of a Community Legal Centre Queensland delegation that visited Canberra to educate politicians about the important work that organisations such as NQWLS do by providing legal assistance to the most vulnerable and disadvantaged in our community. Hayley sits on a number of committees including the Queensland Law Society Domestic Violence Committee, the Children and Families Legal Assistance Forum steering committee and is Treasurer of Community Legal Centre Queensland, all of which actively contribute to law and policy reform.

#### **Domestic Violence Legal Service**

During the past year the Domestic Violence Legal Service (DVLS) continued to assist some of the most vulnerable and at risk women in our community. Operating since April 2016 the DVLS is a holistic, wrap around complex casework service that provides legal and non legal support to address all of a woman's needs, not just her legal needs. Demand for the service remains high with the two solicitors working hard to provide legal advice and assistance as well as representation in court to women in a wide range of legal matters, including domestic and family violence, family law, child protection, Victim Assist, tenancy, credit and debt.

2018 saw the DVLS team evolve to include a social worker for the first time in NQWLS history. All DVLS clients are offered the Social Work Service, however it is up to the individual woman as to whether or not she chooses to engage with the service.

The Social Worker provides emotional support to women as they work through their legal issues with the lawyer, as well as practical support to help address the multiple and often complex practical issues facing many women. This can include assistance with safety planning, accessing housing, applying for Centrelink, dealing with the Child Support Agency, obtaining Emergency Relief payments as well as engaging with counselling and health services.

The Social Worker also assists the DVLS lawyers to understand the broader issues and needs of the women for whom they are providing legal advice and representation.

The addition of a Social Worker to the DVLS team has further improved the ability of the service to secure positive, life changing outcomes for women who have or are experiencing domestic and family violence.

#### COMMUNITY EVENTS

Community legal centres by their very nature and name are part of the community and NOWLS was again very much a part of the local communities throughout our service area in 2017/2018. NOWLS coordinated the annual "Tackle Domestic Violence" campaign with our partners the NO Cowboys Rugby League Club and JCU Fire Basketball Team. We also hosted a free morning tea in partnership with the Anti-Discrimination Commission Queensland to celebrate International Women's Day, and held our annual movie fundraiser night – this year Mamma Mia 2. The NOWLS team also attended and participated in a number of other community events including:

#### NOWLS IN ACTION

## **Protecting Mum and the Kids**

Mary and her children had been exposed to physical and emotional abuse for 15 years by Mary's alcoholic husband, Tom. One of Mary's older children had been forced to leave the house at only 13 years of age because the level of abuse he received was so intense. The other four younger children remaining at home had not fared much better. When Tom put his hands around the youngest child's neck and lifted him off the ground, just prior to Christmas, Mary finally found the courage to take the children and flee the family home. This left Mary and the children homeless and couch surfing, many miles from their hometown. Mary came to see NOWLS who helped Mary file an urgent protection order application, seeking an ouster condition to remove Tom from the house so that Mary and the children could return to their home. NOWLS was then able to assist Mary at the Domestic Violence Court at the first mention of the application and appeared in Mary's matter. The ouster was granted, along with an extensive temporary protection order that protected Mary and her children from further abuse. Mary and her children were able to return to their home, just in time for the first day of school. As the matter was transferred to a court closer to Mary's hometown, the NQWLS solicitor contacted the DV Liaison Officer at the local police station and put him in touch with Mary for further assistance and to 'flag' Mary's house. This was of great comfort to Mary, who lives on a rural property and needs quick attendance by police should any situations arise in the future. Mary said she and the kids felt safer now than at any time before.

## Safe and Settled Family

Brittany had fled South Australia to North Queensland at the recommendation of the Police. She was escorted with the children by Police to the local airport and John followed, continuing to create fear and havoc. Brittany came to North Queensland because she had close family here and it was the only place she felt safe. She was petrified that John would find her and the children.

Brittany had a domestic violence order from South Australia but for some reason the Queensland Police Service ('QPS') were not recognising the Order. John continued to breach the Order and the QPS continued to tell Brittany that there was nothing they could do. Brittany suffered with mental health issues, had physical impairments and she had three (3) children under eight (8) years old. John was their Father. She was feeling completely overwhelmed as John continued to threaten that he would come and take the children. He was taking to social media and making threats and accusations against Brittany. She was terrified that John would follow through with his threats as he had done so many things to hurt her and the children in the past. John had committed significant acts of domestic violence against Brittany of which the children had also experienced and been exposed to. This included John holding Brittany against her will, strangling her on various occasions until she was unconscious and physically smacking her in the head to the point where she also lost consciousness. The list of things that John had done to her and the children was endless. John had spent time in custody for these offence but had been released on parole.

Brittany was initially referred to NOWLS through one of our Outreach clinics at the Women's services in North Queensland. She had not had a chance to apply for Legal Aid

as she was overwhelmed and petrified of what John would do if he found her and the children. She was concerned that she would have to wait a long time for Legal Aid to be approved and John's behaviour was escalating.

NOWLS assisted Brittany with filing an urgent Application in the Domestic Violence Court to have the Order made in South Australia recognised in North Queensland and to add additional conditions to ensure she and the children were protected. NOWLS attended Court on every occasion with Brittany and Brittany also had the support of the Family Violence Support Worker to debrief and have an emotional hand to hold through this particularly stressful time. The Court eventually made a Final Order recognising the South Australian Order and adding all the additional conditions sought for a period of five (5) years. NOWLS assisted Brittany to report the breaches of the Order to the QPS.

NOWLS also assisted Brittany to put forward a proposal for John to spend time with the children. This proposal prioritised the children's safety but enabled them to have a relationship with their Father whilst ensuring that John could not find out where they were located. This also reduced the risk of John filing an Application in the Federal Circuit Court of Australia to seek that Brittany and the children be returned to South Australia as Brittany was extremely concerned about John doing this due to his threats.

Brittany was extremely grateful for the assistance from NQWLS. She said that she finally felt safe and that she and her children can finally begin their lives again close to the support of her family and friends. She recommenced study and is considering returning to work on a part-time basis. Brittany told the NQWLS lawyer that she had changed her and her children's lives and that she would be forever grateful. She said that you can't underestimate what if feels like to finally feel safe.



#### **Moving Forward**

Dorothy approached NQWLS seeking help with making a complaint of sexual assault against the Reverend at her local Church.

Dorothy lived in a small Far North Queensland community. She had an intellectual disability and was particularly vulnerable. Dorothy had reported the assault to the Police, however she withdrew her statement as one of the Reverend's family members worked at the local Police station and she did not feel comfortable continuing with her complaint.

NOWLS helped Dorothy write to the area's Bishop setting out her allegations. NOWLS represented Dorothy and provided her with support and advice throughout the lengthy investigative process. The solicitor explained each step of the process to Dorothy and attended every interview with the Church investigator to ensure that Dorothy

understood what was happening and that her allegations were clearly understood. NOWLS also made sure that Dorothy was getting the counseling and support she required along the way to recover from the assault. Finally, after 2 ½ years the Church Professional Standards Board determined that the Reverend had behaved in a sexually inappropriate manner towards her and recommended a number of actions be undertaken to address his behaviour and ensure that it didn't happen again. Although Dorothy was somewhat disappointed in the outcome, as the Reverend did not lose his position in the Church, she was very happy that the Church had believed her allegations and extremely grateful to NQWLS without whom she could not have continued through such a long, traumatic investigation. The result has provided Dorothy with some closure and she is now trying to move forward with her life.




