QUALITY, ACCESSIBLE LEGAL SERVICES

QWLS' vision is access to justice for all women living in North and Far North Queensland. To this end, during 2018/2019, NQWLS provided over 2,200 women with nearly 12,000 services including legal advice, assistance with preparing documents, drafting correspondence, representation in court, support and guidance through the legal process, information and referrals. To deliver services throughout such a large service area, basically the top half of Queensland, and to often highly vulnerable women, NQWLS employed a variety of strategies to ensure that as many women as possible could access the legal help they needed when they needed it.

Face to face appointments were provided to women who resided within the Cairns and Townsville areas. Monthly face to face appointments were also available at 8 Outreach Advice Clinics, at Atherton, Mareeba, Innisfail, Mossman, Port Douglas, Ayr, Ingham and Charters Towers. Additional Outreach Advice appointments were also delivered through our Skype hotspots at Cooktown, Kuranda, Ravenshoe, Mt Isa, Mackay and the Whitsundays. Women who lived in more regional, rural or remote areas were able to access free legal help through phone appointments or by calling the 1800 advice line which operated Monday to Thursday from 9.00am to 1.00pm and allowed them to speak directly to a solicitor wherever they resided within the NQWLS service area. Evening telephone appointments delivered by our wonderful volunteer solicitors allowed women, for whom daytime appointments were problematic, to receive the advice that they needed.

Every week NQWLS solicitors attended the Cairns and Townsville Magistrates Court to provide a Duty Lawyer service to women who had domestic violence matters before the Court. The value of the Service cannot be understated as attending court can be a traumatic and overwhelming experience.

For many women this trauma is compounded by the fear of having to face their abuser in Court and the knowledge that the lawyer will speak on their behalf and that someone "has their back" provides some level of comfort and support.

NQWLS also assisted through the Family Advocacy and Support Service (FASS) providing legal help and representation to women who were attending the Cairns and Townsville Federal Circuit Courts for family law proceedings where domestic and family violence is an issue. The family law system is even more overwhelming and complicated than the domestic violence system and many women unfortunately are in the position of having to represent themselves. FASS allows these women to receive support, legal advice at court and representation in court if necessary. Again, the benefit of such a service cannot be overestimated.

Although the combined efforts of staff, students and volunteers provided so many women with so much assistance, unfortunately there were still far too many women who NQWLS could not assist. Nearly 9,000 calls to the 1800 Advice Line were unable to be answered due to lack of resources. At times, women were waiting up to 3 weeks for a face to face appointment.

Domestic Violence Legal Service

The Domestic Violence Legal Service (DVLS) is funded under the Commonwealth Government Women's Safety Package (WSP) initiatives. It is a holistic, wrap around service model which provides intensive legal and non-legal support and casework assistance to women with very high risk or vulnerability due to family or domestic violence.

The DVLS consists of 2 lawyers and a client support worker, who offer a 'Rolls Royce' level of service, addressing all of the legal and support needs that are impacting upon the woman in connection to the domestic violence.

Referrals to the DVLS come from far and wide across the NQWLS service region from women's services and other community organisations. Other referrals are made internally, arising from the range of core services provided by NQWLS including the duty lawyer services and outreach services.

We are grateful that the Commonwealth Attorney General's Department has extended the WSP funding beyond 30 June 2019, at the same time increasing the level of funding to also now prioritise the financial support needs of women escaping violence and striving to re-establish their lives.


The Final Report of the independent evaluation of the WSP funded services has confirmed that this holistic service model is making a big difference for those women fortunate enough to have access to it.

We can only hope that this level of service can increasingly be provided to all women in need, through further increases in funding.

Community Legal Education

The NQWLS mission to advocate for and empower women by providing free, accessible, high quality legal advice and assistance was achieved through the services delivered as outlined previously. The other, equally important part of the NQWLS mission, is to work holistically with the broader community by providing education to address injustice and inequity experienced by women. Knowledge is power, and a central component of all community legal centre work is providing information and education to the community about their rights, the law and the legal system.

The year 2018/2019 again saw NQWLS deliver Community Legal Education (CLE) sessions to different audiences through a variety of mediums. Webinars were delivered through Ask Nola, the NQWLS' free membership based online legal resource, on topics including child birth maintenance expenses, tenancy and domestic violence, out of time property applications and an over view of local legal and non-legal support services. The Ask Nola website also contains a wealth of legal information, fact sheets, resources and a referral database for community workers to help them assist their clients to identify and take steps to deal with their legal issues.

NQWLS PEOPLE

2018/19 saw many changes to the staff team, including more history making 'firsts' for NQWLS.

- Principal Solicitor Hayley Grainger was appointed to the newly created Assistant Director role to help overcome some of the challenges that are inherent in overseeing two offices, nearly 500km apart. DVLS Solicitor Samantha Kelley moved into the Principal Solicitor position and Natasha Busby, the long serving President of the NQWLS Management Committee, joined the specialist DVLS team to fill the position that was vacated as a result of Samantha's appointment. Vice President, Kate Pateman then stepped up as Acting President until the next AGM.
- Further changes to the DVLS team included Social worker Leonie Crowe returning home to Sydney and we were fortunate to have Sally Urquhart fill this role on a temporary basis for 6 months whilst the position was being advertised. Eventually, we welcomed Fiona Glenister as the new Client Support Worker for the DVLS team.
- Supervising Solicitor Sharell O'Brien resigned to take up the Coordinator role of the Mackay Domestic and Family Violence High Risk Team. Solicitor Jodie Woodward took 18 months unpaid leave to step into the Court Coordinator position at the Specialist Domestic Violence Court in Townsville with solicitor Ashleigh Metcalfe joining the Townsville team as a result. Rebecca Grouios also left to return home to Melbourne and Nicky Mitchell joined the Cairns team in December 2018.
- Just recently, in another first, Liz Brown became the third solicitor based in the Cairns office. In Townsville, our DV Court Intake Worker, Toni Millar, accepted full time work in Canberra and Penney Ferguson has capably stepped into that role now.
- NQWLS is exceptionally fortunate to have such dedicated management committee members, staff, volunteers
 and others who have worked incredibly hard during 2018/2019 to provide free legal help for vulnerable women, to
 the greatest extent possible with our human resources.




1800 Legal Advice Line

Demand for access to the 1800 Legal Advice Line also increased by a further 28%.

During 2018-19, NQWLS was only able to answer 1 call in 9 due to limited resources.

This means 8,904 calls went unanswered.







Natalia's Story

atalia's first contact with the NQWLS was with our duty lawyer at the first Court date for her domestic violence matter. She wanted protection for herself and her 4 children, aged from 2 years to 12 years. She wanted an Order that her former partner, the father of the children, be prohibited from contacting her, which meant that he could not have any contact with the children.

Natalia no longer lived in town. She had fled the week before due to her former partner kicking one of the children in the head with a steel capped boot. Natalia had tried to leave at least twice before, but this time, she was determined to not go back. Natalia and the children had endured physical, emotional and verbal abuse from her former partner for at least 15 years. Natalia and the children were called disgusting names daily and were physically intimidated or harmed at least weekly. Natalia's former partner was also sexually violent. She said that she was living in a nightmare, but it was also something that she had strangely become accustomed to.

NQWLS assisted Natalia for 2 years, with both the Domestic Violence matter and her Parenting matter in the Federal Circuit Court

The former partner sought parenting orders that Natalia had to return to town, that they have equal shared parental responsibility, that the children live with him and spend time with her on weekends. Natalia would never agree to these Orders as she feared for the safety of her children in her former partner's care.

Natalia sought Orders which permitted her to permanently relocate, have sole parental responsibility for the children and that the children live with her and that the father spend no time with the children.

NQWLS successfully helped Natalia obtain the Final Orders that she wanted in both the Domestic Violence Court and the Federal Circuit Court. Her Final Parenting Orders included that her former partner would spend no time with the children. Natalia would hopefully never have

to worry about the safety of her children with her former partner again.

During the proceedings, Natalia said that there were still

Natalia said that with the help of NQWLS, her life and the lives of her children has now changed for the better, forever. She thanked her lawyer from the bottom of her heart and said that she could never have left her former partner permanently without the free legal help and support she had received.

times that she still felt like returning to her former partner, even though she knew that would be the worst thing for her and her children. She was riddled with guilt and totally disempowered from years of abuse. She was assisted by NQWLS to ensure that she was emotionally supported by counsellors, and she was linked in with specialised support programs that provided in-home support for survivors of domestic violence. She and the children were protected and supported each time they had to attend Court.

Natalia is now a strong advocate for women who have survived domestic violence. She speaks to local groups and helps other women where she can. She is in a new healthy and respectful relationship and has just given birth to a new child. All her children are achieving above average results at school and have a new lease on life.

NQWLS is now helping Natalia to apply for support through Victim Assist.

Louise's Story

ouise has unfortunately been involved with the child protection system for many years and her children, aged 4 and 6 have been in foster care since birth. She grew up in a remote aboriginal community, before moving to Cairns after her children had been removed from her care. She has a low level of literacy, an intellectual impairment and English is not her first language (though she understands and speaks it quite well).

For many years, Louise has felt as though she has been unable to explain to Child Safety how she is feeling, and to be assertive enough to ask for more contact with her children. Everything has been dictated by Child Safety and because of the clear power imbalance between the parties, she has often gone without proper contact.

Prior to her most recent engagement with NQWLS, Louise had to be relocated out of the Cairns region due to ongoing domestic violence towards her by the father of the children. She had not had any contact with her children for a few months. She worried that now she had moved to another region where the children did not live, she would not be able to have any contact with them at all.

NQWLS assisted Louise by supporting her at a meeting with Child Safety. In the meeting, a case plan was developed for the children. NQWLS advocated for Louise and ensured that Child Safety committed to facilitating contact for her with her children. Louise will now have contact with her children each fortnight in Cairns and on school holidays in the region where Louise is now living. Child Safety will pay for her bus fare and will also transport the children for the school holiday contact.

It also became apparent that Louise had no access to any money as her bank did not have a branch in her new town and she had relocated without her photo identification, so she was unable to open a new account with a local bank.

Despite being aware of the vulnerability of Louise, Child Safety had not assisted her with appropriate referrals to culturally appropriate wellbeing services for counselling and general support. NQWLS ensured that Child Safety added an action into the case plan that a departmental cultural practice advisor assist Louise with her banking needs and obtaining new photo identification.

By NQWLS ensuring that Child Safety fulfill their legislative obligations to facilitate contact between a child in foster care and their parent, as well as provide ongoing support to parents with a child in foster care, Louise has been able to make positive changes in her life.

Louise would never have been able to achieve these outcomes on her own. NQWLS will continue to work with Louise with the goal of empowering her to gain confidence to ask for assistance if she needs this in the future, and to advocate for herself and her children.



High School Work Experience - Sophie Says

"Hi, my name is Sophie, and I am a student at St Anthony's Catholic College, currently in year 10, studying business (law included). Over the last couple of days, I have been doing work experience at North Queensland Women's Legal Service (NQWLS), it has been such an eye opener and has really made me more aware and informed about the role of a solicitor/lawyer. I have had so much fun and got the opportunity to work with some incredible people.

The team here at NQWLS is lovely and kind, before coming here I was feeling a little nervous and unsure of what to expect, but they have made me feel so welcomed. They are all incredibly smart, compassionate and driven in their roles at the Legal Service, these ladies have truly made an impact on my future. Seeing all the incredible work, they all do is inspiring. I am very lucky to be a student doing work experience with them. I have got the opportunity to visit the court rooms, collect and send out their mail, write up client feedback reports, make filing folders, various admin jobs, create game templates for an event, and got to talk to some of the other staff about their careers, and learnt so much from them. I cannot begin to explain how much I've learned, I think that coming into any type of work experience it is very important to be open minded, and ready to accept a challenge.

I would like to say thank you all again for giving me this opportunity, I look forward to the future and will hopefully have the opportunity to work with NQWLS again.

You are all amazing, and I appreciate the time you have taken out to teach me, it's something I will never forget. Thankyou for all the dedication and effort you have put in to help me out, it has been a fun experience and I've met some lovely people who have given me advice for my future career as a solicitor. I would especially like to thank Anne for allowing me to work with your staff, and being supportive, it has been the best placement."






